Letter from the President of the Home Owners Association

On behalf of the Board of Directors I welcome you to the inaugural edition of our community newsletter. Now that we have formed a Communications Committee we have the capability of providing our neighbors with up-to-date information concerning important issues, events, and what's happening in our community. We also envision a medium within which we can provide information of a more personal nature about our residents, their families, and their accomplishments.

For this initial issue of our newsletter I want to mention a few timely and important subjects for your information:

The 2013 Budget: The HOA, with the great work done by the various committees, saw the 2012 budget come in "under budget" because we did things smarter than KHOV. However, because of all of the smart things we did in 2012, we are not going to achieve the "under budget" gains in 2013 that we did in 2012. Most of the 2013 budget is known, while the budget line item that carries the most unknown is the one titled "snow removal". So how we deal with this item will influence the 2013 budget.

Mowing & Trash Removal: As we approach the end of the year, the Board is going to ask Home Owners to change the DCCR (Declaration of Covenants, Conditions, and Restrictions) to exempt "grass cutting" and "trash pick-up" as "opt out" services. To change the DCCR, it takes a positive vote of 2/3's of the Dwelling Units, or 81 Dwelling Units. Therefore, please understand that by <u>not</u> voting, it is the same as voting NO. **Please vote**.

The following are some questions that you should ask yourself as you think about this item: If we decide this [grass cutting and trash pick-up] is in fact a special service and allow the opt-out, it will become very management intensive. This is beyond the scope of services of our MSC's contract (because this was not contemplated when they bid the project). Everyone will be paying a different rate. What will be the notice period for opting back in? What if you sell your home during the growing season and you opted out? Is the new owner stuck with no landscaping? How long will we have to get landscapers queued up to mow for the new owner? There will most likely be a surcharge to the Association from MSC to cover this change. Also, are the residents going to be happy with multiple grass cutting companies in our community weekly? Who will monitor mowing? When your neighbor's grass is too tall, who will the complaint go to? What will be an acceptable period to come into compliance, etc? What if you don't come into compliance? Will the Association front the money to have your lawn moved and try to collect it back from you? With regard to "trash pick-up", do you want multiple companies transiting our street on different days at different times? Do you want these heavy trucks using our streets, streets which we own and must maintain? As the President of the HOA, I support changing the DCCR to exempt "grass cutting" and "trash pick-up" as an "opt out" service.

How do we get more people to attend the HOA Meetings: I have been on the board for the past 15 months, and I am surprised that so few residents attend the Board meetings? Any suggestions on increasing attendance will be appreciated.

Congratulations to Sue Stover!

One of our residents, Sue Stover, has been chosen as America's selection to be Artist in Residence at the famous Les Amis De La Grande Vigne Estate in Dinan, France.

The Committee of Les Amis De La Grande Vigne, was created by artist Yvonne Jean-Haffen in 1993 before her passing at age 93. Ms. Jean-Haffen studied art in America and was greatly influenced by her American experience. As a result, she bequeathed her home as a museum and the studio as a place for selected American artists to come and paint the beauties of Brittany. The Committee selects one artist each month from America to come to Dinan, live there in the studio of the estate, and paint for one month.

At the end of the month, the members of the Les Amis De La Grande Vigne select one of the original works painted by the artist of the month for permanent display in the museum. Sue Stover was the American artist selected for October 2012. It is truly an honor for Sue Stover to join the ranks of excellent artists from the United States. Sue departed for France on September 26 and returned home on October 31.

Sue has a degree in Commercial Art from the Art Institute of Pittsburgh. She has taken her art around the world as she traveled with her husband, Jay, and family, painting children's walls in an USAF Base hospital in Japan. She also did play programs and scenery for various Embassy acting groups in Africa and China, as well as landscape oil paintings throughout her travels. Currently, Sue is teaching a beginner's art class at the Clubhouse




