

Lakeside Common Area Cleanup Plans

Residents on Mistland Trail petitioned the Landscape Committee and the Board of Directors to allow them to clear the underbrush and top trees in the Common Area along the lakefront, behind their homes. The work is being done at no expense to the HOA, but rather paid for by the respective



homeowner, and will be supervised by a certified arborist. The Virginia Forestry and Wildlife Group and the Van

Yahres Tree Company met with homeowners to determine the scope of the work. Afterwards, those homeowners who wanted to proceed were asked to submit a proposal to the Landscape Committee, who in turn sought Board Approval.

There have been major changes to the visibility of Lake Rucker as seen from the Common Area pathway since the homes were built. Much of the overgrowth is in the form of invasive nonnative plant species that are choking out other plant life on the lakeside. The scope of the work involves the removal of dead and invasive species trees in such a manner that will not disrupt the soil. Similarly, invasive native and non-native plant species will be removed in an environmentally safe manner. When application of pesticides is warranted, aquatic safe preparations will be employed. No root structures will be removed so as to retain the integrity of the lakeside soil and embankment and all debris will be removed from the site of the work. Because of the tenacity of some invasive species, the entire removal process will take at least two years.

Greg and Laurie Redfern summed it up nicely. "Having a two-year plan in place using Virginia Forestry & Wildlife Group, in conjunction with Van Yahres certified arborists, will ensure all residents will be able to see the lake and enjoy seeing the abundant wildlife while they walk on the path. No one will run the risk of being cut by thorns jutting out from invasive species as they access the walking path, a common problem in the spring and summer months. The two wonderful Hickory trees, which we think are unique to our community, will be majestic and assured healthy growth."

We encountered no rocks and few tree roots, yet the forest around us was notable for the variety and size of the trees. Some trees seemed to be in excess of 100 feet. Close to our turn-around point, we couldn't miss seeing a recently fallen tree sporting the largest span of roots we had ever seen.

We would be pleased to add other names to our list of hikers. If you think you might like to join us, we leave every Wednesday from the Clubhouse at 9:00 a.m. sharp. Bring water and a smile. During the summer we leave at 8:00 a.m. to avoid some of the summer heat.

Book Review

Jefferson, the Army, and the Internet: How to Strengthen National Security, the Economy and Grassroots Communities

Harvey Meyerson is a friend and was a neighbor when he and wife Gladi lived here in Four Seasons, They now live in Hawaii.





Harvey has pursued successive careers as a journalist, congressional staffer, a scholar with a doctorate in American history, and policy analyst at a think-tank headquartered in the Library of Congress, and a staff member of the late Senator Spark Matsunaga of Hawaii. His books include a prize-winning report on the Vietnam war from the perspective of a province in the Mekong Delta and a scholarly Study of American domestic nation-building during the nineteenth century.

In *Jefferson, The Army, and The Internet,* Harvey takes us back to the early days of the development of America and how Thomas Jefferson, the father of West Point, manufactured the Army's early development, leading the drive west, developing outposts for early settlers, and helping to resolve Indian and settler difficulties. When the Civilian Conservation Corps came under the presidency of Franklin Delano Roosevelt, it needed leadership and the Army provided that leadership.

Harvey eloquently takes us through all of that

history and brings us to present day and how the Army could provide that leadership to our young millennials to lead us in the 21st century's quest to deal with the Cyber Threat. The



mission of Harvey's new American Resilience Corps (ARC) would be to maximize the entrepreneurial potential of the Internet and digital manufacturing by spreading it out into rural/small towns. This would make America less vulnerable to crippling cyber or other threats to over centralized critical infrastructure, including a national grid upon which Americans depend for virtually all essential services. It's a civilian-military mission in our nation's best tradition that would transform American and inspire the world.

Both Amazon and Barnes & Noble have the book available for \$16. I've seen quite a number of five star reviews. It was a good read and I enjoyed it!

Building & Streets Report

The Building and Streets Committee has been very active since the last newsletter. We meet monthly to identify and discuss repair issues for the Clubhouse (inside and outside), the streets and walking path, street lights, sidewalks, the gatehouse and the entrance tower. The committee is pleased to report that the following projects recently have been completed:

- 1. Aged straps were replaced on the pool rescue board and the AED has been serviced and is functioning normally.
- 2. The damaged barricade on Stodghill has been replaced and the Four Seasons Drive southern barricade was repaired.
- 3. Interior clubhouse overhead lights are being converted to LED for longer life. They are functioning well.
- 4. The large tree by the entrance tower was removed for improved visibility.
- 5. A large external crack under the back window of the lounge has been sealed and caulked.
- 6. The Dectron system appears to be functioning normally for the first time in many months.

Ongoing projects include:

- 1. MSC has scheduled the gatehouse roof and cupolas repair for 2017.
- 2. MSC will arrange for repair of sidewalks with Building and Streets Committee/Board of Directors input.
- 3. Cleaning and painting of clubhouse gutters.
- 4. Researching replacement earphone jacks for the exercise room.
- 5. Refurbish benches on the walking path and replace the damaged "no trespassing" sign in conjunction with the Landscape Committee.
- 6. The Building and Streets Committee and the Social Committee have formed a subcommittee who, in conjunction with Jeannie, meet when appropriate to review, discuss, and approve/deny events to be held at the clubhouse. There have been three this quarter.

The B & S Committee welcomes Chuck Probst to its ranks, which now has a full complement of members. Current members include: Joe Reece (co-chair), Tim Meyer (co-chair), Bill Groening (secretary), Spencer Crute, Len Lattiak, John Widomski, and Jim Wilson (board liaison).

Our committee invites residents to attend our meetings on the 4th Wednesday of each month at 10:00 a.m. to voice concerns and offer suggestions.

Zoning *

For those of you who are concerned about areas of blight in Greene County, the Board of Supervisors is in discussion about creating a Blight Ordinance. It requires manpower and methods of enforcing the law before it becomes law. Stay tuned.

Greene County Board of Supervisors governs the issuance of Special Permits and Variances. It is a legislative process. Noncompliance results in a formal Notice of non-compliance and if that produces no results, a fine.

At this time there are no shelters for homeless or abused individuals in Greene. They are referred to Charlottesville for assistance.

REMINDER: Factoid about waters in VA: According to Commonwealth of VA code, 62.-44.2, : The waters in VA – That is ALL streams, ponds, rivulets etc. are subject to protection from contamination, and chemical pollution. The issue includes drainage from those areas, which are also subject to protection. So be careful where you dump your garden spray and car washing leftovers!
